The Mission Youth Soccer League (MYSL) promotes a year round soccer program for youths from 5 to 19 years old. Teams registering with the MYSL are expected to participate in the soccer program throughout the seasonal year, which runs from August through August of the following year. MYSL is affiliated with the California Youth Soccer Association ("CalNorth") and SAY Soccer.

2021-2022 COACHES / TEAM MANAGER COMMITMENT LETTER

PLEASE INITIAL EACH LINE

_____ I have received and read a copy of the MYSL Rules and I pledge to abide by them.

_____ I understand that the time commitment to this team is for one full soccer season and that I will be responsible for relaying information to all parents and players relating to the team throughout the seasonal year.

_____ I understand that I will be held liable for the submission of any registration paperwork for myself and other players/team officials of this team and will ensure that all information and any documents presented, for registration purposes will be accurate and will conform to the MYSL, CalNorth and SAY rules.

_____ I understand that if for any reason I have provided false documentation knowingly I will be subject to disciplinary action, which can result in being banned from the MYSL or any of the other leagues.

_____ I understand that the team manager will be the only contact person for all registration matters related to the following teams and I will actively discourage other coaches and parents to contact MYSL or other soccer officials regarding paperwork status or issues.

_____ I acknowledge that MYSL has deadlines and procedures for registration paperwork and that my failure to comply with the deadlines and procedures will result in a processing delay or the failure to process paperwork.

_____ I understand that all coaches, trainers and managers must comply with MYSL rules including rules regarding coaching licenses, live scans, concussion training, SafeSport training and I will insure compliance with the rules prior to any interaction with players.

_____ I understand that MYSL teams must provide certain information to SF DCYF and I agree to cooperate and comply with all DCYF related requirements, including the timely completion of attendance sheets and youth surveys.

_____ I understand that the San Francisco Recreation & Parks Dept has rules and conditions regarding access to fields and that there are severe penalties for noncompliance with the rules and conditions. I understand that I will be held liable for compliance with SFRP rules and conditions, including the submission of any registration paperwork. Further, I understand that MYSL will not be responsible for any penalties or fees imposed on my team due to failure to meet the conditions or noncompliance with the rules.

_____ I acknowledge that MYSL has final approval regarding the placement of teams in leagues, tournaments and cups when fees for such competitions are being provided by MYSL.

_____ I understand that I cannot and will not poach, scout or actively recruit, directly or indirectly, a player of another team for any future participation on any of my team(s) for any reason.

_____ I understand that all fees pertaining to my team must be paid when due and that my team will not be registered if the minimum number of players has not been met. I will be responsible for any late fees associated with not meeting given registration or entry deadlines.

_____ I understand that no player transfer will be approved if any fees remain unpaid to MYSL, other leagues, coaches or community centers and that no player transfer will be allowed prior to December 1, of the seasonal year, for any reason.

_____ I understand a player is committed to play for their team of registration for the entire Fall season. Repeated abuses of guest player privileges that violate the player's team commitment may mean a loss of player transfer privileges.

_____ I understand that, as a MYSL coach, I must operate as a volunteer and not receive compensation for any coaching or team management activity, or I must disclose to the MYSL Board that I receive compensation.

_____ I understand that I will be responsible for the behavior of my team's other coaches, parents and spectators.

_____ I understand that I must comply with the rules of any playing league that any of my teams participates in.

_____ I understand that I must collect all required waivers and forms prior to allowing any player to participate in any soccer activities.

_____ I commit to resolving any issues within MYSL and will refrain from appealing to any other organizations.

_____ I understand that I will not make any derogatory remarks, gestures or use profanity to any referees as defined by the following guidelines;

CalNorth PIM 08-3 Minimum Penalties 4:05:02

E. Referee Abuse: *Referee abuse is a verbal statement or physical act not resulting in bodily contact which implies or threatens physical harm to a referee or the referee's property or equipment.*

All Age Groups – *Suspend for a minimum of four (4) games.*

F. Referee Assault: *Referee assault is an intentional act of physical violence at or upon a referee.*

All Age Groups – *Suspend for a minimum of one (1) year and review by the Board of Directors regarding further disciplinary action.*

As the Coach/Team Manager I have read the above statements and pledge to abide by them and all league rules. I understand that any violation of the above statements may be referred to the MYSL Disciplinary Committee.
